OF ORLANDIA HEIGHTS SPECIAL

TO BE HELD BY SPECIAL MAIL BALLOT  
ELECTION**

To be held on September 11, 2007, as provided by Ordinance No. 18-07 of the City Council of the City of DeBary, FL, adopted on July 11, 2007.

Notice is hereby given that a referendum will be held in the City of DeBary, FL on September 11, 2007 by Special Mail Ballot Election. The registered electors within the Orlandia Heights subdivision residential community shall decide through referendum whether a special residential improvement district will be re-established for purposes of levying a special assessment to undertake roadway repair to protect the health, safety and welfare of the residents of the Orlandia Heights subdivision residential community. The holding of such referendum by special mail ballot election has been authorized by Ordinance No. 18-07 of the City Council of the City of DeBary adopted on July 11, 2007.

In accordance with the Constitution and the laws of the State of Florida, all qualified electors within the Orlandia Heights subdivision residential community of the City of DeBary, Florida shall be entitled to vote in the referendum to which this notice pertains by complying with the instructions the elector receives by mail with the official ballot, including mailing, delivering, or having delivered the marked ballot so that it reaches the supervisor of elections no later than 7 pm on September 11, 2007, the day of the election. The ballot must be returned in the return-mailing envelope provided therewith.

The City of DeBary shall be authorized to create the Orlandia Heights Special Neighborhood Improvement District only if such creation has been approved by the majority of the qualified electors within the Orlandia Heights subdivision residential community of the City of DeBary.
